Ideal Township Board Meeting, September 11th, 2023

The meeting was called to order by Board Chair Peterson at the Townhall at 7:00 p.m. with the Pledge of Allegiance. Supervisor Bilek, Fire Department Chief One/Clerk Wallace, Chief Two Hanson, and 2 residents were in attendance.

Motion by Bilek, second by Peterson to approve the minutes of the August 14th Board Meeting and the August 24th Special Meeting as presented. Carried unanimously.

Supervisor Bilek presented the Planning and Zoning report as follows:

- 1. Rick and Karyn Penn were here to discuss their variance request. Their property is on Clamshell Lake. Bilek attended the site visit on Thursday, September 7th and found no problems with the request. Rick explained what they are planning on doing to their existing deck and new deck. Motion by Bilek, second by Peterson to approve the variance recommendation for an OHW setback of 59 feet to proposed deck, where 75 feet is required. Carried unanimously.
- 2. Motion by Bilek, second by Peterson to approve the land use map amendment recommendation for Pat Ebnet. Carried unanimously. Pat was here last month to discuss this request for splitting 29 agricultural/forestry district acres into 2.5 rural residential acre lots down Partridge Trail.

Fire Chief Two Hanson presented the Fire Department report as follows:

- 1. Run report for August shows 14 medical, 1 motor vehicle accident with injury, 1 power line down, 1 grass fire, 1 CO detector activation and 1 false alarm. YTD runs 87.
- 2. Beef feed went well, Hanson thanked the volunteers for their help and residents for attending.
- 3. There were no safety incidents.

Board Chair Peterson presented the Road and Bridge report as follows:

- 1. The 2021 plow truck was in for some warranty work and completed.
- 2. Peterson and the Maintenance Supervisor are planning on doing the annual road review next week.
- 3. Peterson provided an update on the Buschmann Road reconstruction project. There should be a cost estimate for construction by November.
- 4. The maintenance department has been shouldering, mowing, and continuing the storm cleanup.

Supervisor Bilek presented the Transfer Station report as follows:

- 1. The month of August receipts were \$17,214 that's \$3,454 less than August of 2022.
- 2. Year to date receipts is \$124,812, that is \$12,676 more than YTD 2022.
- 3. 2023 Permits sold YTD is 1,847.
- 4. The Transfer Station Attendants will be going to the Crow Wing County Landfill to get familiar with their operation in early October.

Clerk Wallace presented the Buildings, Grounds, Parks & Recreation report as follows:

- 1. We have now received the full amount requested of \$15,000 from the MN Twins Community Fund for the Ball Field.
- 2. The Township received a bid for concrete curb in front of the park of \$13,391.37 from Anderson Brothers. Anderson Brothers also made a bid for paving the parking lot by the ball field. These bids will be discussed at future meetings.

Nothing to report on Legislative and Research.

The Clerk/Treasurer presented the Treasurer's report and Claims for Payment as follows:

- 1. Every year the board needs to certify the levy that was voted on by the residents of the Township at the annual meeting in March. Motion by Peterson, second by Bilek to certify the 2024 levy as approved by the Township residents at the annual meeting. Carried unanimously.
- 2. Motion by Peterson, second by Bilek to accept the treasurer's report for August as presented. Report includes receipts #6985 through #7015, totaling \$71,437.03. Disbursements #FNBNBOB812023 through #PERA08302023 totaling \$130,729.61. Carried unanimously.
- 3. The Clerk/Treasurer read and reviewed the September claims for payment with the Town Board. Motion by Peterson, second by Bilek to approve the September claims as read, claims #46538 through #46580 totaling \$24,111.09. Carried unanimously.

Other Business brought before the Board:

Motion by Peterson, second by Bilek to stay with Blue Cross Blue Shield for full time employee's health insurance in 2024. Carried unanimously.

There being no further business to conduct, the meeting was adjourned at 7:44 pm.

WHEREAS: The Township of Ideal is authorized to join the Statewide Volunteer Firefighter Plan

administered by the Public Employees Retirement Association (PERA); and

WHEREAS: The Township and the Township's Fire Department Relief Association have jointly

consented to and obtained a cost analysis for joining the Statewide Volunteer Firefighter

Plan from PERA not more than 120 days ago; and

WHEREAS: The Township highly values the contributions of Ideal Fire Department members to the

safety and well being of our community and wishes to safeguard their pension

investments in a prudent manner; and

WHEREAS: The existing service pension level for the Ideal Fire Department is currently at the

\$3,600 pension level per year of service pursuant to current relief association bylaws.

NOW THEREFORE, BE IT RESOLVED BY THE TOWN BOARD OF THE TOWNSHIP OF IDEAL, MINNESOTA:

- 1) The Township of Ideal hereby approves coverage by and requests participation in the Statewide Volunteer Firefighter Plan administered by PERA under the terms provided in the PERA cost analysis at the \$4,000 pension level per year of service, effective January 1, 2024; and
- 2) The Township of Ideal hereby approves coverage by and requests participation in the Statewide Volunteer Firefighter Plan administered by PERA under the terms provided in the PERA cost analysis with the vesting schedule beginning at 40% after 5 years of service, increasing by 4% each year until 100% vesting is reached after 20 years of service; and
- 3) The Town Clerk/Treasurer and Township Board Chair are hereby authorized to execute all documents necessary to effectuate the intent of this resolution.

RESOLUTION #2023-07

Ideal Township Crow Wing County, Minnesota

A RESOLUTION TO ERECT REGULATORY SPEED SIGNS IN RURAL RESIDENTIAL DISTRICTS

WHEREAS, Minn. Stat. § 169.14, subd. 2(a)(8) establishes a 35 m.p.h. speed limit on town roads in rural residential districts;

WHEREAS, a "rural residential district" is defined in Minn. Stat. § 169.011, subd. 69a, as "the territory contiguous to and including any ... town road that is built up with visible dwelling houses situated at intervals averaging less than 300 feet or less for a quarter mile or more.";

WHEREAS, Minn. Stat. § 169.14, subd. 2(c) indicates that a 35 m.p.h. speed limit on a designated rural residential roadway is not effective unless the signs are erected designating the speed limit and indicating the beginning and end of the residential roadway on which the speed limit applies;

WHEREAS, the town board has determined, as a result of on-site inspections, the following roads are within a rural residential district as defined above:

Butternut Point Road – 1.517 miles starting at County Road 16 Father Foley Drive – 1.434 miles starting at County Road 134 Old Whiskey Road – 1.987 miles starting at County Road 145 Strawberry Lake Road – 1.360 miles starting at County Road 39 Wildamere Drive – 1.400 miles starting at Heath Drive

WHEREAS, as a town road(s) within a rural residential district the legislature has established the speed limit to be 35 m.p.h. without the need for a speed study by the Minnesota Department of Transportation;

NOW, THEREFORE, BE IT RESOLVED, by the town board of Ideal Township, Crow Wing County, Minnesota that 35 m.p.h. regulatory speed limit signs be erected on the above described roads in accordance with the Minnesota Uniform Manual on Traffic Control Devices.
